PROCLAMATION OF SANCTUARY, PEACE, AND PROSPERITY

By His Majesty King David Joel, Crown Sovereign of the House of Wemyss/Weems and of the Ancient House and Kingdom of David, a Kingdom and Throne of Crown Sovereign Kings bearing an Ecumenical and Ecclesiastical Mantle under the Everlasting Covenant sworn by the Living God to David.

This Proclamation of Sanctuary, Peace, and Prosperity is a covenantal contract between the Crown Sovereign of the House and Kingdom of David and its Citizens, governing internal rights, duties, and protections within the Kingdom.

This Proclamation of Sanctuary, Peace, and Prosperity is issued in harmony with, and under the authority of, the World Notice of the House and Kingdom of David, memorialized and sealed in the Internal Kingdom Library as Canon of Record.

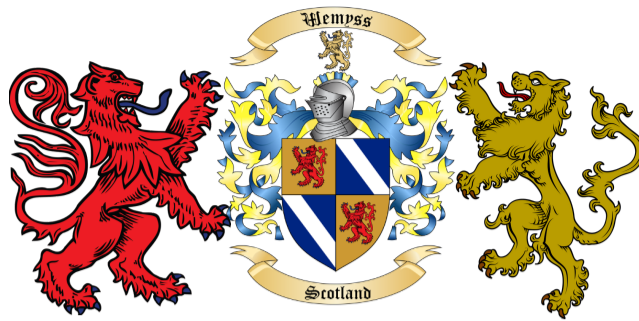
Who I Am and the Mandate of Restoration

I am His Majesty King David Joel, Crown Sovereign of the House of Wemyss/Weems and of the House and Kingdom of David. I am a direct descendant of Abraham (my one hundred and thirty-seventh great-grandfather), Isaac (my one hundred and thirty-sixth great-grandfather), Jacob (my one hundred and thirty-fifth great-grandfather), and Judah (my one hundred and thirty-fourth great-grandfather); I am the one hundred and twenty-fourth great-grandchild of King David of Judah and Israel and the one hundred and twenty-third great-grandchild of King Solomon of Judah and Israel. King Zedekiah is my one hundred and seventh great-grandfather. King Malcolm the Third and Queen Margaret (Saint Margaret) are my thirty-first

great-grandparents. My line continues through the succeeding kings of Judah and into the High Kings of Ireland and Scotland by way of the House of Wemyss/Weems. The full genealogical record is preserved on the House and Kingdom of David website and may be consulted there for the complete lineage.

Called by covenant and by the weight of a holy commission, my life is given to the restoration of covenantal order: to reestablish lawful protections for the living, to secure families, and to rebuild institutions that honor God and the dignity of persons. This Proclamation is the public articulation of that heavenly mandate; it gathers the faithful, instructs the seeker, and offers sanctuary and law together so that those who come may find refuge, justice, and the hope of a people restored to Mount Zion. 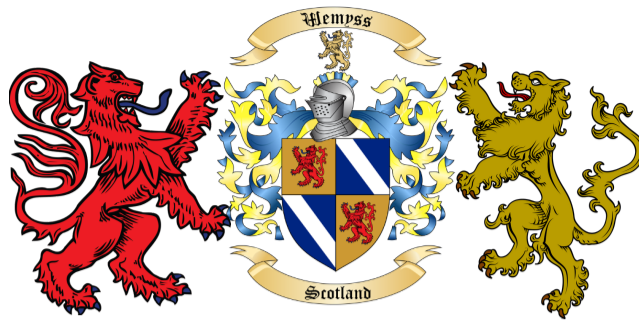
The House and Kingdom of David stand as a Kingdom and Throne of Crown Sovereign Kings, by Royal Authority and Divine Mandate, bearing an Ecumenical and Ecclesiastical Mantle; and each King derives his sovereignty from the Everlasting Covenant sworn by the Living God to David. As it was written, so it is declared: the Throne of David shall not lack a man to sit upon it before the Lord forever. In this age, that Covenant is upheld. Therefore, neither the courts of men nor the instruments of foreign dominions may presume to possess jurisdiction over His Majesty's Crown, the institutions of the Kingdom, or the Citizens thereof. Jurisdiction rests alone in Covenant — in Heaven above, and, upon the earth, in the Ecumenical and Ecclesiastical Combined Courts under the Crown.

Royal Preface

Beloved: I speak to you as one who has seen desolation and has been given a charge to call the faithful to repair what has been broken. Like Nehemiah who surveyed the ruined walls and said, "Come, let us rise and build" (Nehemiah 2:17–18, ESV), the Crown summons workers of mercy and of law to rebuild sanctuaries of life, family, and justice. This Proclamation is first a pastoral summons — a word to the heart — and then a lawful instrument: it teaches as it declares, comforts as it commands, and provides the recorded protections by which the living may find shelter.

The heavenly mandate that animates this work is no mere aspiration but a promise of renewal. As the Spirit raised dry bones to life, "I will put my Spirit in you, and you shall live" (Ezekiel 37:14, ESV), so we labor toward spiritual and civic resurrection: communities healed, courts that restore, markets that bless, and families made whole. We look toward the vision of the New Jerusalem — "Then I saw a new heaven and a new earth... and I saw the holy city, new Jerusalem" (Revelation 21:1–2, ESV) — not to replace the Lamb's heavenly register, but to manifest its signs on earth through covenantal life, faithful worship, and righteous governance. We hold also this summons of hope for a people restored to Mount Zion: "But you have come to Mount Zion and to the living God, the heavenly Jerusalem, and to innumerable angels in festal gathering, and to the assembly of the firstborn who are enrolled in heaven... and to Jesus, the mediator of a new covenant, and to the sprinkled blood that speaks a better word than the blood of Abel" (Hebrews 12:22–23, ESV).

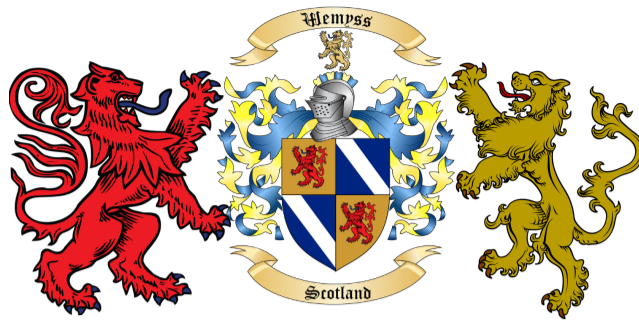
Therefore this Proclamation binds pastoral word and legal covenant together. It offers sanctuary as mercy and as recorded law; it invites seekers into instruction and fellowship; and it establishes procedures so that those who come may be entered into the Kingdom's records with the surety of protection. Read these words as both invitation and charge: come with faith, bring skill and humility, and together let us rebuild a people for Mount Zion and for the glory of God.

The present age is marked by systems that commodify life and press upon conscience. Technologies and institutions have been used to coerce and to reduce persons to account numbers. Many find themselves forced to choose between livelihood and bodily integrity. To such as hunger for a lawful refuge, the Crown extends an offer: an alternative polity grounded in divine law, pastoral care, and covenantal responsibility. This Proclamation declares the principles, protections, and procedures that constitute that refuge.

Those who respond to this call shall be formed as a Kingdom of Priests: a people who teach righteousness, intercede for the nations, and steward public life. The Kingdom's life is shaped by covenants — mutual pledges that bind both ruler and ruled to duty, protection, and sanctified liberty.

Preamble

I, His Majesty King David Joel, Crown Sovereign of the House and Kingdom of David, being moved by a profound sense of duty toward the Living God and a deep compassion for the dignity of the living person, do hereby establish this Preamble as the spiritual and legal gateway to this Proclamation of Sanctuary, Peace, and Prosperity.

In an age where the structures of men have become increasingly mechanical, impersonal, and coercive—treating the breath of life as a mere data point and the sanctity of the body as a commercial asset—the Crown asserts a higher Law. We recognize that true governance is not found in the accumulation of power, but in the provision of Sanctuary; not in the enforcement of mandates, but in the cultivation of Peace; and not in the extraction of wealth, but in the stewardship of Prosperity for all who dwell within the shadow of this Throne.

This Proclamation is our response to the cry of the faithful who seek a refuge where conscience is honored, where bodily integrity is sacrosanct, and where the ancient Covenants of God are restored to their rightful place as the foundation of human society. We do not merely offer a set of rules, but a way of life—a Kingdom of Priests and a Society for Life—where every record entered into the Internal Kingdom Library serves as a witness to the restoration of Mount Zion.

Therefore, let it be understood by all Peoples, Nations, and Authorities: this Preamble serves as the solemn declaration of our intent to repair the breach, to restore the paths to dwell in, and to provide a lawful and holy harbor for the living. Under the authority of the Everlasting Covenant, and in the presence of the innumerable angels in festal gathering, we set forth these Precepts and Acts as the governing constitution of our Sanctuary.

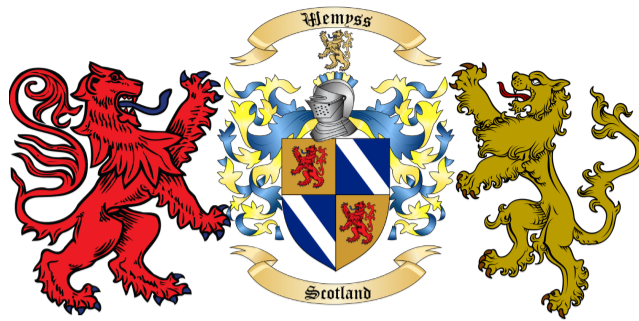
Precept One

Factual Context

Act One: Modern administrative, corporate and technological systems regularly reduce living persons to registries, identifiers, and contractual statuses. These mechanisms are used to obligate, condition, or limit biological persons by

reference to corporate, statutory, or regulatory identities that are separate from actual living persons.

Act Two: Consequences observed include compelled medical procedures, involuntary data capture of biometric and genetic information, administrative reclassification of persons, and the enforcement of mandates through employment, insurance, licensing, or public benefits. These phenomena create material conflicts between conscience, bodily integrity, and livelihood.

Precept Two

Legal and Moral Foundation — Authority for Action

Act One: This Proclamation is issued under the Royal Authority and grounded in the duty to protect the living. It affirms that law exists to serve living persons and that covenantal obligations take precedence over instruments that treat life as an economic or corporate object.

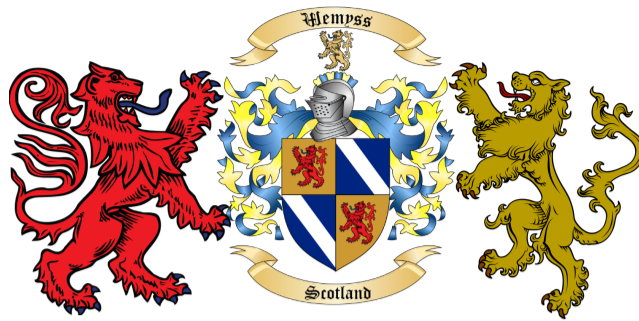

Act Three: “Technological intrusion”: any intentional capture, modification, or permanent recording of biological data (including but not limited to DNA, biometrics, or implanted identifiers) without the free, informed, written consent of the living person.

Act Four: “Declaration of Non-Consent”: the personal written instrument by which a living person records withdrawal of consent to specified practices; this term will be used throughout the Proclamation in full.

Precept Four

Scope of Protections and what this Proclamation does now

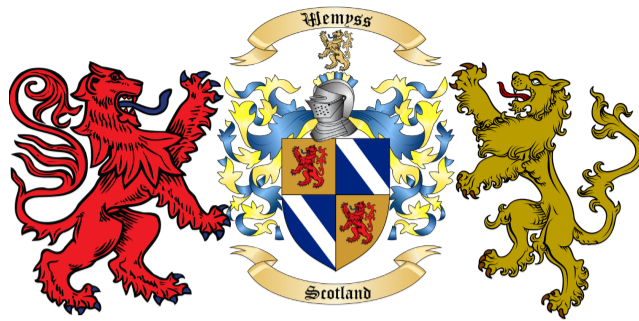
Act One: Recognizes and reaffirms the inalienable right of each living person to bodily integrity and to refuse medical or technological interventions absent free, informed, written consent.

Act Two: Provides a direct, recorded remedy pathway: instruments (including the Declaration of Non-Consent) will be received by the Court of the Ekklesia, assigned a Court Record Number, and issued a certified copy. The Crown’s Division Three — the King’s Court for Royal Prerogatives — will maintain archival entries (the Book of Life) for instruments affecting status, claims of right, and royal writs.

Act Three: Enables immediate emergency relief: upon presentation of prima facie evidence that an interference with bodily integrity is occurring or imminent, the Kingdom’s clerks may request provisional injunctive orders and coordination with local enforcement where lawfully possible.

Precept Five

Procedural Summary

How a Person Obtains and Enforces Protection

- Act One:** Recordation: A living person executes a Declaration of Non-Consent (or other specified instrument) and presents it to the Court of the Ekklesia either in person, by authenticated submission, or by a registered representative. The instrument is recorded, assigned a Court Record Number, and a certified copy is issued to the Declarant.
- Act Two:** Registry correction: The Court will assist in administrative correction procedures for governmental and private registries where reclassification has occurred, using Letters Patent, certified orders, and Writs of Entry as appropriate.
- Act Three:** Remedies: Available remedies include preliminary injunctions to halt coercive acts, declaratory orders confirming status, restitution or correction of records, Letters Patent to perfect claims of right, and escalation to Division Three for royal writs and archival entry.

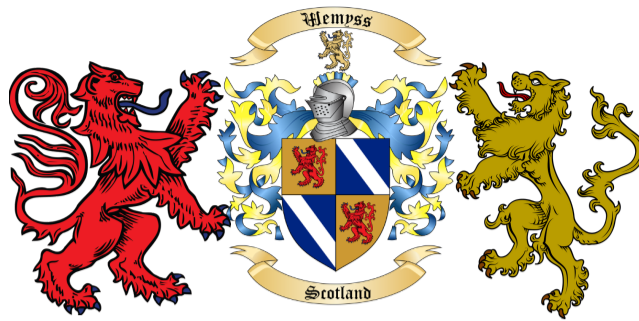
Limitations and Interfacing with External Jurisdictions

Practical Boundaries

- Act One:** This Proclamation establishes internal Kingdom protections and remedies for Citizens and those who voluntarily accept Kingdom authority. It does not, by itself, override sovereign laws of other states; where cross-jurisdictional conflict arises the Crown will pursue comity, negotiation, and diplomatic remedies while prioritizing pastoral care and lawful protective measures available to Citizens.

Act Two: Where external enforcement is required, Kingdom remedies will seek the least invasive, most legally defensible means to protect the living person (e.g., injunctive cooperation, diplomatic engagement, private arbitration, or treaty mechanisms as available).

Precept Seven

Implementation and Accountability

Immediate Steps the Crown Directs

Act One: The Court of the Ekklesia shall publish the procedures and forms (including the Declaration of Non-Consent) and maintain a staff of clerks trained to receive instruments and to issue Court Record Numbers within stated turn-around times.

Act Two: Division Three — the King's Court for Royal Prerogatives — will hold the Book of Life for final archival entries and will issue Royal Writs where extraordinary remedial authority is required.

Act Three: The Crown charges an Office of Record Integrity to audit recordation processes, ensure certified copies are issued, and to report quarterly on cases, remedial outcomes, and administrative backlog.

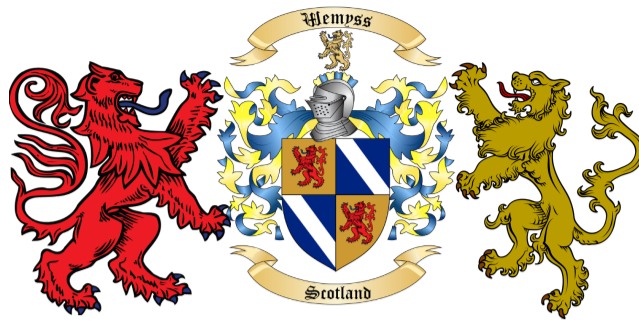

Precept Nine

Acceptance of the Offer of Sanctuary, Peace, and Prosperity

An individual desiring to accept the Crown Sovereign of the House of David and King of the Kingdom of David's Offer to Contract by Application for Citizenship in the Kingdom of David's Exclusive D'Vida Living Society, a Society for Life as the Society that each accepted Applicant become a Citizen under the umbrella of the Kingdom of David and its Ecumenical and Ecclesiastical Court under its superior Jurisdiction and in accordance with the immunities and protections offered therein. Those protections, immunities, and responsibilities are set forth herein as follow:

Act One: On Sanctuary

The Kingdom affirms the God-given dominion of each living person over their body, blood, bones, and DNA, while reserving sovereignty in its strict sense to the Crown and Throne under Covenant.

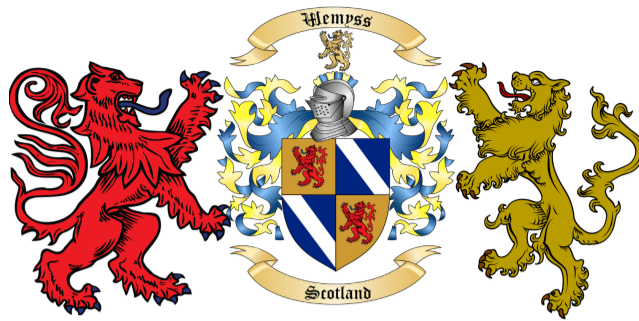
The protection is both pastoral and juridical. It includes injunctive relief, priority access to Kingdom courts, administrative assistance to correct public records and status, and pastoral care for restoration. The Declaration of Non-Consent is the personal instrument by which a Declarant withdraws consent to unlawful mandates; it shall be recorded with the Court of the Ekklesia, assigned a Court Record Number, and a certified copy issued to the Declarant. Final archival entry may be made in Division Three — the King's Court for Royal Prerogatives (the Book of Life).

Purpose

- A. Sanctuary protects the bodily integrity, dignity, and autonomous will of every living person who voluntarily places themselves under the Kingdom's protection. The Crown declares that no person shall be subject to involuntary medical or technological procedures without their free, informed, written consent.

Scriptural Anchor

“He will cover you with his pinions, and under his wings you will find refuge” (Psalm 91:4, ESV).

1. Definitions: (for clarity and enforcement)

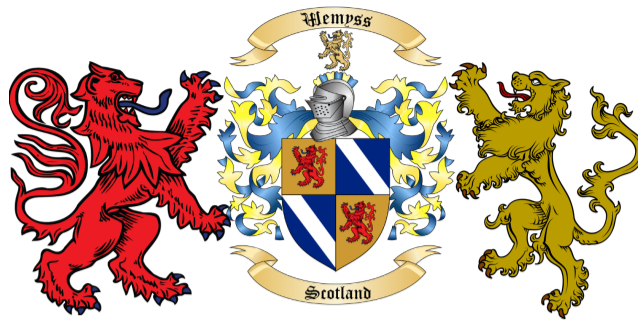
- a) “Living person”: a human being of flesh and blood possessing bodily integrity and conscience; not a corporate fiction.
- b) “Bodily integrity”: the right of a living person to control their own body, blood, DNA, and biological processes.
- c) “Technological intrusion”: any capture, recording, modification, implantation, or permanent association of biological or biometric data (including DNA, microchips, implants, biometric scans, or permanent digital identity tokens) without the free, informed, written consent of the living person.
- d) “Medical intervention”: any invasive or non-invasive procedure, treatment, experimental protocol, vaccination, or therapeutic regimen that alters bodily function or biological status.
- e) “Declaration of Non-Consent”: the written instrument by which a living person records the withdrawal of consent to specified medical, genetic, or technological practices. This phrase will be used in full throughout Kingdom records.

B. Scope of Protections (what Sanctuary covers)

1. Protection against compelled medical interventions, experimental treatments, genetic capture, forced vaccination, biometric implantation, and any technology that materially alters or permanently records a person’s biological signature without free, informed, written consent.
2. Protection extends to coercive environments where consent is manufactured through economic pressure, employment requirement, licensing condition, or conditional access to public benefits.
3. Protection supports correction of public and private records that inaccurately or unlawfully reflect a person’s status or consent.

C. Available Remedies (how Sanctuary is enforced)

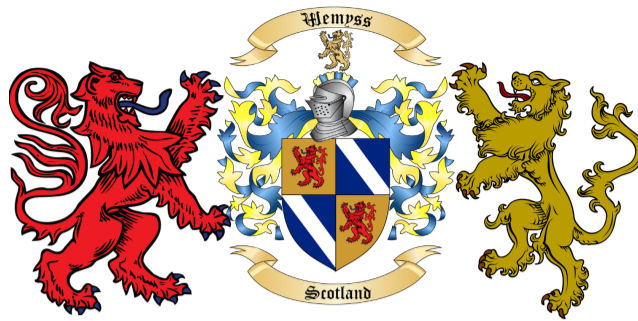
1. Immediate provisional relief: clerks and judges in the Court of the Ekklesia may issue provisional injunctive orders to halt an imminent interference when prima facie evidence is presented. Emergency review aims to be initiated within twenty-four to seventy-two hours of receipt of prima facie evidence.
2. Declaratory orders: the Court may issue declarations confirming the status, rights, and protections of the living person under Kingdom law.
3. Registry remedies: Letters Patent, Writs of Entry, and certified court orders to correct or suppress unlawful records in governmental or private databases.
4. Restitution and corrective remedies: orders to restore records, rescind unlawful identifiers, and to award restitution where property, employment, or liberty was impaired.
5. Escalation and archival: where extraordinary remedial authority is necessary, matters may be escalated to Division Three — the King's Court for Royal Prerogatives — for Royal Writs and archival entry in the Book of Life.

D. Procedural Standards (how a person obtains recordation and relief)

1. Recordation standard: the Court of the Ekklesia will acknowledge receipt of any Declaration of Non-Consent within forty-eight hours and shall record the instrument, assign a Court Record Number, and issue a certified copy ordinarily within five business days.
2. Emergency procedure: a prima facie emergency petition may be filed with the Court of the Ekklesia at any hour; on such filing the clerk shall notify a duty magistrate and seek provisional relief within twenty-four to seventy-two hours dependent on urgency.
3. Registry correction procedure: after recordation, the Court will provide a certified order and procedural packet for use in administrative correction with third-party registries, including suggested statutory authorities and sample submission templates.
4. Standard of proof: provisional relief requires a credible prima facie showing of imminent or ongoing interference; final relief follows established evidentiary standards set by the Court in its rules (documented in Annex A).

E. Evidence and Burden (what a Declarant should provide)

1. Minimum evidentiary checklist for recordation and preliminary relief: (a) sworn declaration or affidavit by the Declarant; (b) government or private registry documents showing the contested entry (if available); (c) contemporaneous notices, employment directives, or medical orders evidencing coercion; (d) witness statements or supporting declarations where available; (e) any physical or electronic proof of technological capture (photographs of implants, screenshots of orders, medical records).
2. The Crown's clerks will assist Declarants in assembling evidence and may accept verified proxy submissions when Declarants are incapacitated.

F. Interaction with Employers, Institutions, and Third Parties

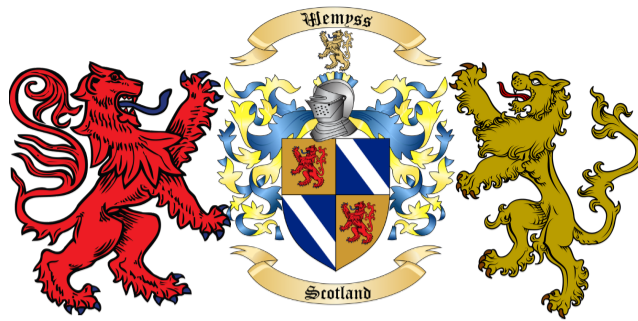
1. Upon issuance of a Court Record Number and certified record, the Declarant may serve certified notice on employers, licensing boards, health care providers, insurers, and other relevant third parties demanding cessation of coercive action and correction of records. The Court will provide sample certified notices and guidance.
2. The Crown recommends that employers and institutions adopt policies recognizing the Declaration of Non-Consent as binding on matters of employment and access within the Kingdom's jurisdictions; refusal to comply with certified orders may be remedied through injunctive relief and claims for restitution.

G. Emergency and Protective Practices (field actions)

1. Sanctuary teams: the Crown will establish pastoral-legal response teams to provide immediate protective assistance, pastoral care, and coordination with local enforcement and legal counsel.

2. Temporary harbor: where safe and lawful, the Kingdom's local sanctuaries may provide temporary protective harbor while the Court processes recordation and relief. Harbor is subject to lawful limits and the safety of the community.

H. Interface with External Jurisdictions (practical boundaries)

1. Kingdom remedies are internal and rely on comity and lawful cooperation when external sovereign authorities are involved. This Proclamation does not, by itself, nullify foreign sovereign law. Where cross-jurisdictional complications exist, the Crown will pursue diplomatic, arbitral, and cooperative remedies while seeking to preserve the Declarant's protections through provisional orders and rapid advocacy.

I. Sample form language — Declaration of Non-Consent (illustrative excerpt)

1. "I, [full legal name], a living person of flesh and blood, declare under penalty of perjury that I withhold and withdraw all consent to any medical intervention, genetic capture, biometric implantation, or technological intrusion that would alter my bodily integrity or permanently record my biological signature, except where I give prior, free, informed, and written consent. I request that this Declaration of Non-Consent be recorded by the Court of the Ekklesia, assigned a Court Record Number, and that a certified copy be issued to me. I request provisional protective relief where lawful and necessary to prevent imminent interference. Signed: _____ Date: _____."

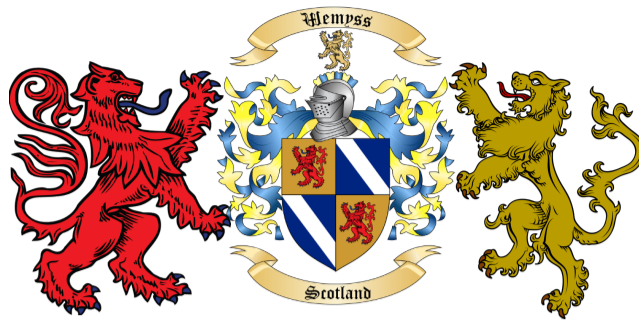
J. Implementation, oversight, and audit

1. The Court of the Ekklesia shall publish rules implementing this Precept and an evidence checklist in Annex A.
2. The Office of Record Integrity will audit recordation and remedial processes quarterly, publish summaries of remedial outcomes, and recommend operational improvements.
3. Clerks and officers who receive instruments shall be trained in trauma-sensitive pastoral intake, evidentiary triage, and rapid procedural routing.

K. Accountability and appeal

1. Decisions by the Court of the Ekklesia may be appealed to Division Three — the King's Court for Royal Prerogatives — under established rules of appellate procedure. Emergency provisional orders remain in effect during any appeal unless set aside by a higher court.

Act Two: On Peace

Peace in the Kingdom is active, ordered, and restorative. The Kingdom will establish courts of equity and forums of reconciliation that aim to restore persons rather than punish. Where cross-jurisdictional issues arise, the Crown shall pursue comity and diplomatic arrangements to protect Citizens abroad and secure peaceful settlements.

Scriptural anchor

'Pray for the peace of Jerusalem! May they be secure who love you!' (Psalm 122:6, ESV).

'He shall judge between the nations and shall decide disputes for many peoples; and they shall beat their swords into plowshares...' (Isaiah 2:4, ESV).

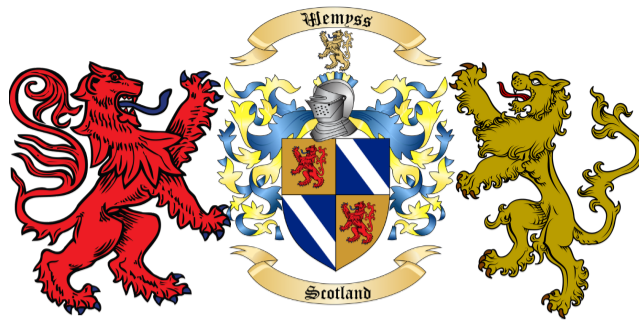

1. 'Peace': public order characterized by safety, justice, and the restoration of right relations among persons and institutions.
2. 'Restorative process': a structured method (mediation, facilitated dialogue, restorative circle, or reconciliation covenant) aimed at making amends, securing restitution, and rehabilitating relationships.

3. 'Forum of reconciliation': a Kingdom-authorized body (local conciliatory court, mediation panel, or reconciliation council) empowered to facilitate restorative remedies and to recommend or issue binding orders where parties have consented to Kingdom adjudication.
4. 'Victim-centered remedy': a remedial outcome that privileges the safety, dignity, and reparative needs of persons harmed, including restitution, apology, restoration of access, and protective measures.

B. Scope of Protections and Aims (what Peace covers)

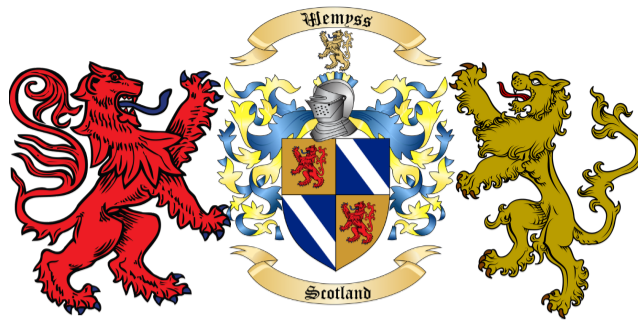
1. Protection against lawlessness, coercive institutional practices, and public harms that destabilize families and communities.
2. Provision of accessible restorative processes for interpersonal and communal disputes, including family conflicts, neighborhood disputes, commercial disagreements with relational harm, and institutional abuses where remedy is sought.
3. Priority pastoral and protective attention to cases involving violence, abuse, or imminent risk; in such cases, interim protective orders and coordination with lawful enforcement may be requested.

C. Available Remedies (how Peace is enforced and restored)

1. Restorative agreements: mediated covenants between parties that specify restitution, labor, financial remedy, or service undertaken to repair harm. When voluntarily submitted to the Forum of Reconciliation and recorded, such agreements may be converted to enforceable Kingdom orders.
2. Protective and provisional orders: where danger or ongoing harm is demonstrated, the Forum or duty magistrate may issue provisional protective orders to secure safety pending full hearing.

3. Restitution and correction: orders to return property, compensate for loss, correct records, and repair reputational injury.
4. Community remedies: assignment to supervised community service, participation in restorative education, or placement in supervised reconciliation programs.
5. Sanctions for bad faith: where a party abuses process or refuses to comply with recorded remedial orders, the Forum may impose sanctions, including binding enforcement measures and referral to Division Three for Royal Writs where necessary.

D. Procedural Standards (how a matter moves through Kingdom peace processes)

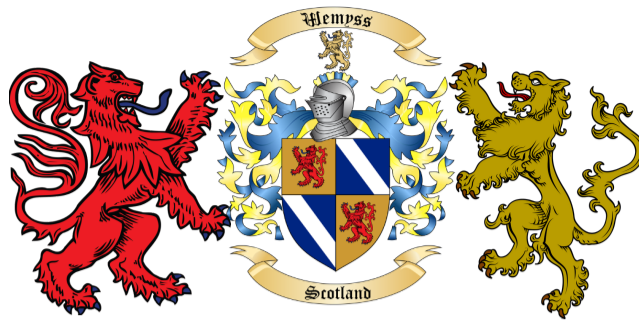
1. Intake and triage: matters are initially received by local clerks or pastoral intake officers who perform a triage within seventy-two hours to determine urgency, appropriate forum, and risk profile.
2. Referral to appropriate forum: low-risk cases are offered facilitated mediation or restorative circle; higher-risk cases receive formal hearings with evidentiary procedures.
3. Timelines: where parties consent to mediation, initial sessions shall commence within fourteen days of intake except for reasonable cause; for provisional protective orders, the duty magistrate will consider emergency relief within twenty-four to seventy-two hours.
4. Consent and voluntariness: restorative processes require voluntary participation; where a party declines Kingdom mediation but seeks judicial remedy, the Court of the Ekklesia will proceed to adjudication under Kingdom rules if jurisdiction is properly invoked.

E. Evidence and Burden (what must be shown)

1. Standard evidentiary norms apply according to the nature of the proceeding: provisional relief requires credible prima facie evidence of imminent harm; adjudicative orders require the preponderance of admissible evidence unless a higher standard is specified by Kingdom rule.

2. The Forum accepts written declarations, witness testimonies, documentary evidence, expert reports, and pastoral attestations. Clerks assist parties in assembling necessary documentation.

F. Interaction with Criminal Matters and External Authorities

1. The Kingdom's restorative processes are not a substitute for criminal prosecution in external sovereign systems where criminal conduct is alleged; the Crown will cooperate with lawful criminal investigations while pursuing parallel restorative remedies for victims where appropriate and where such cooperation does not compromise safety.
2. Where external enforcement or criminal detention affects a Citizen or party, the Kingdom will seek comity, diplomatic engagement, and lawful advocacy to protect rights and preserve opportunities for restorative remedy.

G. Community Structures and Preventative Measures

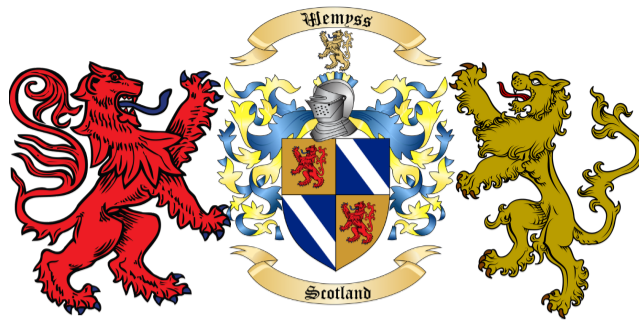
1. Reconciliation Councils: each local Kingdom community will maintain a Reconciliation Council composed of trained mediators, elders, pastoral officers, and legal clerks to oversee mediation rosters and restorative programs.
2. Training and prevention: the Crown will fund and require training in conflict de-escalation, trauma-informed mediation, and restorative practices for clerks, magistrates, and community leaders.
3. Public education: dissemination of civic curricula promoting neighborly responsibility, covenantal obligations, and the Kingdom's restorative norms.

H. Emergency Protocols and Victim Safety

1. Immediate safety first: in cases of violence or imminent threat, the Forum prioritizes protective orders, safe harbor, and rapid pastoral support. Sanctuary teams (pastoral-legal teams) shall coordinate emergency needs, medical referrals, and temporary shelter.

2. Victim-centered process design: all restorative work with victims shall be conducted with consent, confidentiality protections, and trauma-informed safeguards. The Kingdom may appoint victim advocates to represent victim interests in negotiations.

I. Recordation, Enforcement, and Remedies Attachment

1. Restorative agreements and Forum orders may be recorded with the Court of the Ekklesia and assigned a Court Record Number. Recorded orders carry enforceable status within the Kingdom's jurisdiction and may be the basis for Letters Patent or other enforcement instruments where lawful.
2. The Court will publish standard forms for recording agreements and a prescribed process for seeking conversion of voluntary agreements into enforceable orders.

J. Implementation, Oversight, and Audit

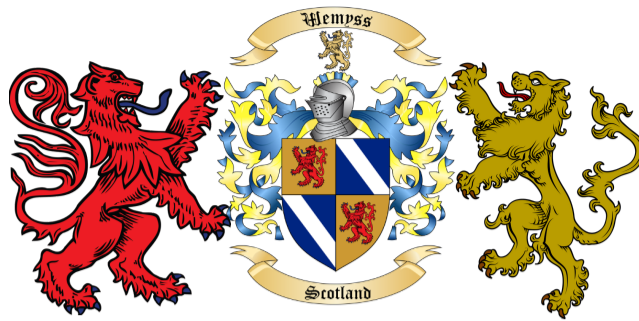
1. The Forum of Reconciliation will publish its rules of practice, standards for mediators, and the ethical code governing restorative work.

Act Four: On Civilization

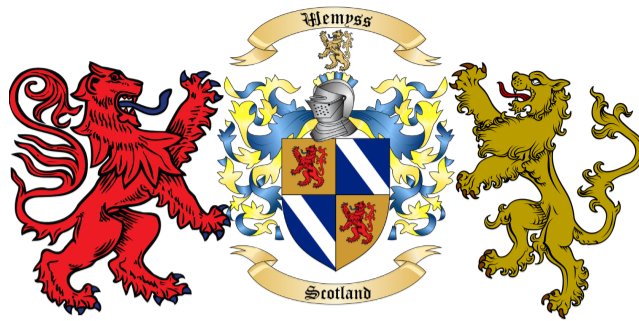
Civilization under the Crown cultivates learning, worship, art, and lawful institutions that transmit virtue across generations. Citizens are assured the integrity of family life, freedom to found schools of sacred and civic learning, and protection of cultural goods. International cultural cooperation and educational treaties are defined in the Treaty of Peace, Prosperity, Commerce, and Civilization and in the GKM-OM regarding Treaties.

Maxim One: The Sanctity of the Living Person

1. The living person is primary. Law and policy exist to protect bodily integrity, conscience, and personhood. (Scriptural anchor: Genesis 1; Psalm 139.)

Maxim Two: Covenantal Responsibility

1. All public life is shaped by covenants binding ruler and ruled in mutual duty, protection, and sanctified liberty. Covenants carry moral and recorded force.

Maxim Three: Stewardship and Subsidiarity

1. Resources and authority should be exercised nearest those they affect. Higher authority supports, does not supplant, local stewardship and family governance.

Maxim Four: Restorative Justice

1. Remedies favor healing, restitution, and restoration over mere punishment; where punishment is necessary it is subordinated to repair and rehabilitation.

Maxim Five: Hospitality and Sanctuary

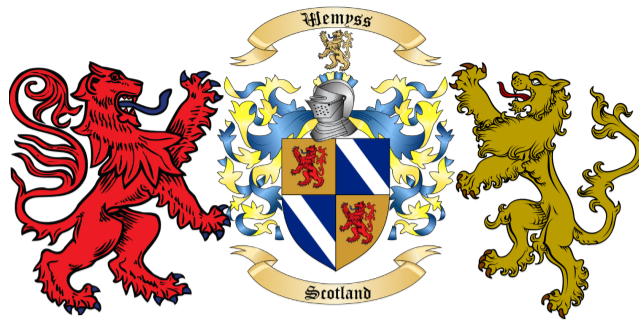

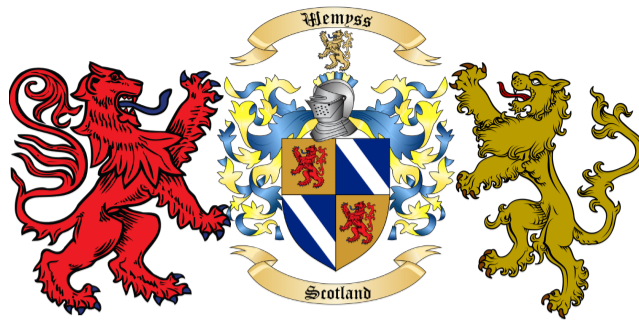

Pastoral Syllabus and Safeguards

Purpose: Provide pastoral teaching on angelic realities, discernment, and appropriate church/priestly practices while protecting against error and spiritual abuse.

Doctrinal note (ESV basis): Teachings are rooted in Scripture (examples: Psalm 91; Hebrews 12; Ezekiel 37; Revelation 12) and in cautious ecclesial tradition; experiential claims are evaluated by doctrine, fruit, and community accountability.

Syllabus (teaching objectives)

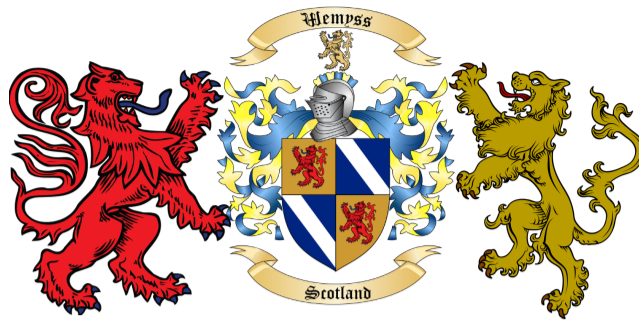
- Session One: Biblical foundations — nature, roles, and limits of angels.
- Session Two: Discernment — how to test spiritual impressions and differentiate from personal projection or deception.
